- 1) That the accommodation provided for each of the several classes are sufficient for the minimum number of pupils taught there in and is properly ventilated and lighted.
- 2) That the latrine arrangements are adequate and maintained satisfactorily and also kept clean & maintain with the bleaching powder and phenyl.
- 3) That the supply of drinking water is wholesome and that in all other necessary aspects the sanitation is good.
- 4) Drinking water source should be chlorinated daily.
- 5) That the building is maintained in substantial repair.
- 6) Adequate fire precautionary measures should be provided.
- 7) Adequate Emergency Exit should be provided.
- 8) Rain Water Harvest structure must be provided in the premises.
- 9) The water tanks (Sintex/Cement tank) in the campus should be kept clean by protecting it from mosquitoes, the wastages like plastic items, broken bottles and unused tyres should be replaced immediately from the rain water. Check every time whether the rain water staged in the terrace.
- 10) In School campus display of sign boards of size 60x30 cm (No Smoking area smoking here is an offence) inside the School.
- 11) In School campus no sale of tobacco in the radius of within 100 yards in the School.
- 12) Conditions to be followed as per R.No.86684/EPI/S1/2020, dated 07.11.2020 (Instruction of the Chief Secretary meeting regarding SOP of School reopening held on 05.11.2020)
- 13) Proper cleaning and sanitization should done at the School premises frequently and it should be recorded in a register.
- 14) Hand Sanitizers should be available in each Class room.
- 15) The entire pupils in the School should be screened by IR Thermal scanner daily.
- 16) That essentials such as sanitizers, thermal scanner, disinfectants should available in the premises sufficiently.
- 17) Hand washing facilities should be made in front of each and every buildings in the School.
- 18) Social distancing (atleast 6 feet) should be maintained at all places in the campus.

- 19) IEC materials regarding Covid-19 Preventive measures should be displayed at appropriate places to create awareness.
- 20) No Persons/Students without face mask should be allowed in the campus.
- 21) The school should follow the SOP's updated by the Government then and there.
- 22) This Certificate is valid for one year from the date of issue.
